9. ELECTRICITY :

Raw space / Built-up space : This rate is subject to revision. The organizer will provide Electricity at a suitable point in the stand. International distributors to the Machinery / Equipment will have to be arranged by the Exhibitors Electrical Contractor at their own cost.

10. APPROVAL FOR DESIGN OF STAND :

Every exhibitor will have to submit their stand design for approval prior to 15 October 2017 complete details of Exhibit Electricity and other installation and elevation.

11. EXHIBIT FOR DISPLAY :

Exhibits for display can be brought into the fair grounds from : 14.11.2017

12. DESIGN GUIDELINES :

(a) Grouting , digging in floors or wall is not allowed, Raised wooden platform of not more than 4 inches in height may be allowed.

(b) Painting or nailing (and use of screws) on the partitions supplied under shell scheme is prohibited . Photographs, Charts etc. may be fixed with adhesive tapes or suspended with nylon threads with the help of clamps hooked on the top horizontal channel.

(c) The load bearing capacity of wooden flooring provided by the organizers for indoor space will be 100 kgs per sqm. In case the exhibits are likely to exceed this limit. The Exhibitors may please inform the organizers immediately on confirmation.

(d) Partitions or dividers in the stands should not be erected on the open side of the stand. The height of the partition or divider should not exceed 2.5 mtr. Both sides of partition wall should be properly finished or painted; particularly the partition from the neighbors side should not look unfinished.

13. STAND COMPLETION :

RAW Spaces outdoor start date – 11 November 2017 , end date 14 November 2017. RAW Space Indoor 12 November 2017, end date 14 November 2017. Indoor Built up 14 November 2017, start and finish date.

14. REMOVAL OF EXHIBITS :

All Materials are to be removed by 12 midnight, 18 November 2017. organizer will not be responsible if Exhibitor fails to comply with, conditions enumerated in the Exhibitors information Manual.

15. DAMAGES TO THE EXHIBITION AREA :

Exhibitors will be required to make good all damages or make payment in lieu thereof of Exhibition Area facilities / buildings etc. incurred during settling up and / or Fair Period and / or dismantling period.

16. INSURANCE :

Against all ascertainable risks from transportation to display and removal should be done by the Exhibitors at their cost. The organizer will in no way be responsible.

17. SOUND :

Sound level with the stall should be within 40 decibels

18. PHOTOGRAPHY :

The organizer reserves the right to photograph any exhibit for their use.

19. CANCELLATION :

If the exhibitor withdraws his participation after confirmation, the organizer reserves the right to forfeit the amount.

20. SETTLEMENT OF DUES :

Any and all expenses chargeable to Exhibitors must be settled before the closure of the fair to ensure smooth removal of goods from the site.

21. DISPUTE RESOLUTION AND GOVERNING LAW :

All unresolved matters, questions, dispute or differences what so ever arising between the exhibitor and organizers shall be settled by arbitration in accordance with the rules of the arbitration and conciliation Act 1997. The arbitration proceedings shall be conducted in the English Language in Kolkata, India. The arbitration agreement contained in this paragraph shall be solely and exclusively governed by the laws of India.

22. FORCE MAJEURE :

If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, national emergency, labor dispute, the non-availability of exhibition premises or any other cause not with the control of the organizers. The organizer may, at their entire discretion, repay the rental paid by the exhibitor, or part thereof, but shall be under no obligation to repay any part of such rental and shall be under no liability in respect of any actions, claims or losses.
